## Month-long operation yields 950 kg narcotics

In a crackdown on inter-state drug traffickers, the Haryana Police, during a month-long anti-drug drive called Operation Dhawst, seized a whopping 950 kg of narcotics. The drive commenced on June 1.

During the period, properties of drug peddlers worth over Rs 2.13 crore were frozen. PK Agrawal, DGP, said during the operation, the police checked 2,223 individuals with a history of offences under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, and history sheets were prepared for 92 habitual...
